Dear Residents,

I thought it would be helpful to say something in this Newsletter about traffic and parking around the school. As we move into autumn and winter, the weather means that inevitably traffic becomes more of an issue, and this is something that Governors have been talking about recently, in relation to the School Travel Plan. All schools are required to have a Travel Plan which sets out the objectives and actions that the school will undertake to promote safe, active and sustainable travel to and from school, with an emphasis on reducing the reliance on private cars. The Travel Plan is reviewed and updated each year by the school and the Governors, and responsibility for that lies with the Resources Committee.

Both the school and Governors are aware of issues relating to car traffic. I live close to the school myself, and I have experienced at first hand some of the issues that arise. Some of you may be aware of the school Safeguarding Policy, which requires that all children up to the start of Year 5 are accompanied to and from school by a responsible person who is at least 16 years old, and obviously some parents will choose to come and go by car.

The Headteacher and the school are aware of the problems this can cause to local residents, and the school do encourage walking and cycling to school and highlight issues with parking regularly in school communications. Additionally, as public awareness of climate change and air quality has increased, many people have also become more aware of the environmental impacts of car use for short journeys, and we are hopeful that this will start to affect the decisions that parents/carers are making about travel to and from school.

Governors have acknowledged that there is a limit to what the school itself can do about traffic, particularly given that the responsibility for roads lies with Surrey County Council and personal responsibility of every adult driving. I have been in touch with our County Councillor about whether there is anything in general the Council are doing to support schools, given their net-zero carbon strategy.

We will be considering whether there are other steps which we might be able to take to help reduce the problems with traffic and parking. Please be aware though that this doesn't guarantee anything - ultimately that is in the hands of parents/carers
